# New CEO Has Strong Educational Commitment

Vance M. Brown, M.D., took over the helm at Bassett Healthcare Network as the President and Chief Executive Officer on July 1, 2014. His career has been marked by leadership in many areas. Among his accomplishments, Brown has demonstrated outstanding dedication and interest in medical education. After medical school training at Yale University School of Medicine, he completed post-graduate training in Emergency Medicine, Internal Medicine, and Family Medicine, with board certification in Medicine and Family Medicine. He received the best resident teacher award in his Family Medicine residency at North Carolina.

Following his training, he joined the faculty at the University of Massachusetts in Worcester, where he distinguished himself as a teacher and scholar, and became the program director for the Family Medicine Residency program at U Mass, where he served until relocating to Cleveland in 1999.

At the Cleveland Clinic, he catalyzed the expansion and development of a department of Family Medicine. This growth was in the context of the Cleveland Clinic starting a researchoriented four-year medical school campus of Case Western Reserve. Here, Brown grew the Department of Family Medicine from 15 to 65 faculty members. Under his leadership, the first Family Medicine residency at the Cleveland Clinic was launched.

In 2010, Brown left the Cleveland Clinic to become the Chief Medical Officer at Maine Health. Maine Health includes Maine Medical Center as its primary academic institution. Brown's role at Maine Health did not directly include teaching of residents or students, but his interest in education continued. At Maine Health, he was the architect of a curriculum in physician leadership.

Brown intends to bring his interest in this curriculum to Bassett, and he is dedicated to the education mission at all levels—nursing and ancillary care, undergraduate medical, postgraduate residency training, and continuing physician education and professional development.

# Updates from the Columbia-Bassett Medical School

On May 21st, the first class of Columbia-Bassett medical students attended their graduation in New York City.

Preceding the official graduation in New York City, there was a celebration in Cooperstown on May 18, 2014. This event, held at The Farmers' Museum, was attended by over 100 faculty members and family, and included an address by Dr. David Hirsh, Dean of Harvard's Cambridge Integrated Clerkship, and brief talks by Drs. Franck and Weil. Columbia-Bassett certificates were presented to each student by a Bassett faculty member.

During the prior week, all Columbia-Bassett students in the class of 2016 and three members of the graduating class took performance improvement certification training in a "Lean Six Sigma Green Belt" program designed for this purpose. Initially developed in the corporate sector, this methodology teaches participants how to analyze and solve quality problems to improve performance, increase customer satisfaction, and reduce work variations. The students and graduates found it to be an amazing learning experience.

On June 6th the Senior Associate Dean of Columbia University College of Physicians and Surgeons, Dr. Lisa Mellman, and the Director of the Center for Education and Research, Dr. Boyd Richards, visited Bassett and gave a talk to over 150 faculty members. They spoke highly of the curriculum and the knowledge they gained from their visit.

Alfred Jaretzki, III, M.D., 1960

#### Alfred Jaretzki III, M.D.

Alfred (Fred) Jaretzki, M.D., a former Bassett Hospital physician whose work on the thymus gland won him an international reputation, died May 29, 2014. He had homes in New York City and Essex, Conn.

At the time of his death, he was professor emeritus of clinical surgery and special lecturer at Columbia Presbyterian Medical Center where he moved after a decade at Bassett. He retired in 1992.

Jaretzki was recruited to Bassett Hospital from Columbia University in 1955 as Associate Surgeon with special training in thoracic and vascular surgery. At the time, there was a plan was to establish pulmonary and even cardiac surgery for Bassett patients. Working with Surgery Resident David Blumenstock, M.D. and others, he established a surgical cardiopulmonary research lab that soon segued into canine organ transplantation studies, particularly of the lung and heart. The work dovetailed with the Nobel-prize winning research on bone-marrow transplantation led by E. Donnall Thomas. M.D. and colleagues in the Department of Medicine. While Jaretzki's plans for human mitral valve surgery at Bassett didn't get off the ground, his work was a decided forerunner of Bassett's cardiac surgery program begun over half a century later.

Jaretzki returned to P&S in 1964, where he continued a distinguished career, notably involving the thymus gland and its relationship to myasthenia gravis. At age 85, he was appointed co-investigator of the clinical research undertaken by the Myasthenia Gravis Task Force funded by the NIH. As Professor Emeritus of Clinical Surgery, he continued contributing until near the time of his death.

His sister Josie Lipman, his children Alfred IV, Lasell Bartlett, Alexander and Sumner, his stepson Adam Isles and his wife Hannah and their children Nina and Peter, and his wife Alexandra survive him.

#### Alberta A. Bowes, R.N.

Alberta Anna Bowes, retired Director of Nursing at the Mary Imogene Bassett Hospital and Army Nursing Corps veteran of World War II, died on June 16, 2014, at Bassett Medical Center. She was 91.

Miss Bowes began her nursing career at Oneonta's Fox Hospital in 1943. From 1944-46 she had a distinguished career in Europe as a Lieutenant in the U.S. Army Nursing Corps, which included two battle stars. After obtaining a Master's

Degree in Nursing Education in 1948 she worked as a Nursing Instructor at the Hartwick College School of Nursing. With a 1949 teaching contract between the School of Nursing and Bassett Hospital in force, she came to Bassett as Assistant Director of Nursing in 1956, and became Director at the retirement of Miss Elizabeth Wilcox in 1968.

Physician staff and trainees of her era will remember her as a very capable, no-nonsense administrator who worked tirelessly to enhance education for nurses and to improve nurse-doctor working relations. In an era when the attending physician was not to be challenged, there were numerous instances when she refused to back down, such as when a certain doctor asked her to take a tray to the kitchen. "What do you want me to do with it?" He said, "well, put it in the kitchen; I want to see this patient." I said, "We don't have a kitchen here any more; the doctors did not put one in. So I can't take care of it." "What do you mean?" he said. I said, "You were on the committee that had no nurse member. You never even thought about a kitchen so we don't have one on this ward." (Quotations from an interview of Miss Bowes in 2009 by Dr. John Davis.)

Alberta Bowes retired in 1982 and as a passionate explorer traveled around the world, among many other activities. In 2004, she moved into Cooperstown's Thanksgiving Home. She is survived by her brother, William Morris Bowes of Cooperstown, and several cousins.



## Dr. Ahmed Wins Outstanding Research Presentation Award

Saeed Ahmed, M.B., B.S., chief internal medicine resident in his fourth year of training at Bassett Medical Center, was presented with this year's E. Donnall Thomas Outstanding Research Presentation Award. Ahmed's research project and poster were among seven recently presented as part of the E. Donnall Thomas Research Day. Ahmed's research study project was titled, "Hyperdynamic Left Ventricle on Radionuclide Myocardial Perfusion Imaging: A Marker of Diastolic Dysfunction."

"Our study highlights that elderly female patients with a normal nuclear stress test and elevated ejection fraction (pump function of the heart) have impaired relaxation of the heart. The higher the ejection fraction the more likely there is impaired relaxation. Relaxation is as important as contraction in heart function. Impaired relaxation can cause a different type of heart failure, which may be ignored by a clinician, especially in a patient with normal nuclear stress test." Echocardiography forms the cornerstone of diagnosis of this type of heart failure. "In the coming years this particular heart dysfunction will become more common—with the aging population and rates of obesity," notes Ahmed. "The study shows the added value of performing an echocardiogram even when other tests are normal."

Ahmed worked on the study project with interventional cardiologist Dhananjai Menzies, M.D., at Bassett Medical Center. "Patients with exertional shortness of breath frequently undergo nuclear stress testing. A normal test result may prompt the ordering physician to seek a non-cardiac cause," said Menzies. "While reading nuclear stress tests, I had noticed that patients with extremely forceful cardiac contraction also had stiffening of the heart muscle, called diastolic dysfunction, an underdiagnosed cause of shortness of breath. This study proved this hypothesis, particularly in elderly women."

Ahmed earned his medical degree from King Edward Medical University in Lahore, Pakistan. He plans to join Bassett Healthcare Network in June as a hospitalist at Bassett Medical Center. His prize-winning research was also published in the *Journal of the American Society of Echocardiography*, in the issue of June 2013.

The E. Donnall Thomas Award is given annually to a Bassett trainee who has conducted exceptional research while at Bassett Medical Center during residency. The award is named in honor of E. Donnall Thomas, who served as Bassett's physician-in-chief from 1955 to 1963. He was awarded the 1990 Nobel Prize in Medicine for his pioneering work in bone marrow transplantation, which he began at Bassett. Thomas performed the world's first human bone marrow transplant at Bassett in 1956.

# Research Day Generates Compelling Projects

The following research projects were completed and submitted by residents and medical students for consideration in the 2014 E. Donnall Thomas Research Poster Day. Bacterial Overgrowth Symptoms in Morbid Obesity: Effect of Roux-en-Y gastric bypass David Fredenberg, M.D.



# Alumni Can Help Secure the Future of Medical Education at Bassett

To grow the medical education endowment and the Columbia-Bassett Medical School scholarship fund, the Friends of Bassett and the Bassett alumni group are asking those who have benefited from medical education here to help support its viability for the future.

#### **Medical Education Endowment Fund**

The medical education endowment was established in 1997 through the generous contributions of alumni to provide support for enhancements to the medical education program. The endowment currently has \$3.5 million in assets. The goal is to increase that asset base to at least \$10 million within the next 10 years in order to provide financial resources for this critical Bassett mission.

A well-funded education program can give Bassett an advantage in attracting high-caliber students and residents as well as clinicians and medical administrators who serve as faculty. A larger endowment will provide the income to enable Bassett to bring in specialists to help design curriculum and to help create objective measurements to demonstrate competencies. Ongoing faculty development will ensure that Bassett's medical education programs will continue to be sophisticated and in-demand.

#### **Medical School Scholarship Fund**

Education at Bassett has evolved from a fourth-year elective program for a few students to a sophisticated joint medical school program with Columbia's College of Physicians and Surgeons.

The Columbia-Bassett Medical School Program recruits students with an interest in providing care in underserved rural communities and in learning how to manage health care systems that promote both quality and cost-effective delivery of care. The program provides a longitudinal curriculum and course of study focused on ethics, evidence-based medicine, health care system management, and leadership for 40 exceptional medical students.

Bassett Medical Center underwrites the cost of education for the students, providing \$30,000 in scholarships per year per student. The scholarship fund supports Bassett's goal of offering financial aid to every student in the Columbia-Bassett program.
